Random example pages were selected to serve as templates for similar content pages, which number over 1,000,000 and therefore cannot all be manually checked. The aim of this report is to find, assess, and address systemic problems should they arise during the evaluation. Other issues which may be hard to locate, such as an image that may have a missing alt tag on an article page, will be addressed as they are found. Likewise, De Gruyter Brill has established a system in quickly locating and correcting accessibility issues as they are discovered or submitted to the product team. This assessment should provide a holistic overview of the site(s) under the De Gruyter Brill umbrella. Additional assessments will be conducted quarterly throughout the year so that the accessibility of De Gruyter Brill's digital products consistently improves.

Evaluation Methods Used

- Testing is based on general product knowledge.
- Testing with assistive technologies (including screen reader; screen magnification; contrast switching; keyboard; speech recognition)
- Testing with automated and manual accessibility testing tools:
 - Browserstack Website Scanner
 - Axe
 - Wave
 - NVDA
 - Chrome Dev Tools
 - Apple (Mac) Voice Reader
